Conversely, inadequate preparation and support can lead to early career burnout and high turnover rates, particularly in high-poverty schools (Ingersoll, 2001). These findings emphasize the need for comprehensive policies that address both the recruitment and retention of quality educators. The importance of teacher retention cannot be overstated. High turnover disrupts student learning, increases recruitment costs, and burdens remaining staff with additional responsibilities. In Texas, for instance, an estimated \$329 million is spent annually due to early teacher attrition (Texas Center for Educational Research, 2000).

Such statistics reflect a broader trend observed globally, where schools in disadvantaged areas experience higher rates of teacher turnover, exacerbating educational inequities (Hanushek, Kain, & Rivkin, 1999). Addressing these challenges requires complex policy interventions. Effective pre-service teacher preparation programs are essential in equipping educators with the necessary skills and knowledge. Ongoing professional development ensures that teachers remain effective throughout their careers. Moreover, competitive compensation and incentives can attract and retain high-quality educators. Recognizing the distinct roles of hygiene factors and motivators, educational institutions can implement targeted strategies to enhance teacher satisfaction and motivation. This holistic approach not only improves teacher quality but also contributes to the overall effectiveness and stability of the educational system. Herzberg's Two-Factor Theory, propounded by Frederick Herzberg in 1959, offers a profound framework for understanding job satisfaction and motivation in the workplace. This theory posits that job factors can be categorized into two distinct groups: hygiene factors and motivators. Hygiene

factors, such as salary, working conditions, and company policies, are extrinsic elements that, if inadequate, lead to job dissatisfaction.

Conversely, motivators, including achievement, recognition, and the nature of the work itself, are intrinsic factors that, when present, enhance job satisfaction and motivation. Importantly, Herzberg argued that the absence of hygiene factors causes dissatisfaction, but their presence alone does not lead to satisfaction; similarly, the presence of motivators leads to satisfaction, but their absence does not necessarily cause dissatisfaction. This dual-factor approach underscores the complexity of employee motivation and highlights the necessity of addressing both sets of factors to foster a motivated and satisfied workforce. In the realm of education, particularly concerning teacher quality and retention, Herzberg's Two-Factor Theory provides valuable insights. Teachers, akin to employees in other sectors, are influenced by both hygiene factors and motivators in their professional lives. The application of this theory to the teaching profession can elucidate the underlying reasons for teacher satisfaction and dissatisfaction, thereby informing strategies to enhance teacher quality and reduce attrition rates.

Hygiene factors in the educational context encompass aspects such as salary, job security, working conditions, administrative support, and school policies. While these factors do not inherently motivate teachers, their inadequacy can lead to job dissatisfaction, which may contribute to high turnover rates. For instance, inadequate compensation, lack of professional development opportunities, and poor working conditions can create an environment where teachers feel undervalued and unsupported, leading to burnout and eventual attrition. Research consistently shows that teachers who receive adequate classroom resources and manageable workloads are more likely to remain in

the profession. Structured investment in teacher professional development including workshops, graduate-level coursework, and online learning modules also plays a critical role in ensuring that teachers continue to grow in their expertise and remain effective over time.

Also, mentorship and induction programs are frequently supported through policy initiatives as a way to support novice teachers in their first critical years. These programs serve as scaffolding, helping early-career Educators Bridge the gap between academic training and the practical realities of classroom management, curriculum delivery, and student engagement. By pairing new teachers with experienced mentors, school systems can improve teacher retention and accelerate professional growth. Well-structured mentorship programs have been shown to reduce teacher attrition by up to 30%, particularly in high-need schools, where the risk of early exit is the highest.

Performance-based incentives and recognition systems also form part of comprehensive policy strategies aimed at boosting teacher retention. These may include salary increments based on evaluations, bonuses for teaching in underserved areas, and awards for instructional excellence. While such incentives must be carefully designed to avoid overemphasis on standardized test outcomes, when balanced with formative assessments and peer reviews, they can affirm teachers' value and encourage continued professional investment.

Retention of such teachers ensures long-term stability, institutional memory, and continued growth within educational communities.

Furthermore, various studies has shown a clear correlation between teacher effectiveness and student achievement. Students taught by highly effective teachers over successive years perform significantly better than those who do not have access to quality instruction (Rivkin et al., 2005). In contrast, students exposed to underperforming teachers for extended periods often struggle to meet academic benchmarks. Therefore, consistent access to skilled teachers is not only important for individual learners but also crucial for addressing broader educational disparities, particularly in under-resourced communities.

Moreover, retaining experienced teachers leads to stronger school cultures. Teachers who remain in their roles for longer periods contribute to mentoring, curriculum planning, and the professional development of new staff. This type of internal support system fosters a collaborative and cohesive work environment, which benefits both teachers and students. According to Ingersoll and Strong (2011), schools with stable teaching staff are better positioned to implement long-term instructional strategies and school improvement initiatives.

Additionally, teacher turnover disrupts learning environments and imposes financial and organizational burdens on school systems. High turnover rates result in increased recruitment and training costs, diminished student-teacher relationships, and loss of instructional continuity. In the United States alone, the cost of replacing a single teacher is estimated to range between \$9,000 and \$21,000, depending on the district (Carroll, 2007). These losses are especially pronounced in high-poverty and rural schools, which often face the greatest difficulty in attracting and retaining qualified personnel.

Although compensation plays a role in retention, working conditions are equally vital. Teachers are more likely to stay in positions where they feel supported, respected, and equipped to succeed. Leadership quality, manageable workloads, and access to professional development are consistently identified as key factors influencing teacher satisfaction (Ladd, 2011). Therefore, improving these areas helps to keep skilled educators in the classroom also enhances the overall effectiveness of schools.

Teacher retention supports equity in education. When high-quality teachers remain in schools serving disadvantaged populations, students who face greater socio-economic barriers are more likely to receive consistent, high-standard instruction. This helps narrow the achievement gap and promote fairness within the educational system (Darling-Hammond, 2010). Policies aimed at improving teacher quality and retention, therefore, do not only serve administrative or economic goals but also uphold the broader mission of education as a tool for social justice. Teacher quality and retention are inseparable priorities for any education system seeking to achieve academic excellence and equity. High-quality teachers drive student achievement, foster a supportive school culture, and reduce institutional costs. Retaining them ensures that these benefits are sustained over time. For these reasons, any serious educational reform must include strong and targeted measures to attract, support, and keep effective teachers in the profession.

CHALLENGES IN TEACHER RECRUITMENT AND RETENTION

Recruiting and retaining qualified teachers remains a major concern for education systems across the world. Several persistent challenges reduce the attractiveness of the profession and contribute to high turnover, particularly in underserved communities. Below are five key challenges that affect both the recruitment and retention of teachers:

Poor Working Conditions

Many teachers leave the profession due to unfavorable working environments. These include overcrowded classrooms, lack of resources, outdated facilities, and excessive administrative tasks that reduce time for instruction and planning. In addition, some teachers report unsafe school environments, particularly in under-resourced urban and rural schools. Such conditions make the profession less appealing to new entrants and increase burnout among existing teachers. When teachers do not feel supported or equipped to perform their duties effectively, their likelihood of remaining in the profession decreases significantly.

Inadequate Compensation

Low salaries are a major deterrent to both entering and remaining in the teaching profession. In many regions, teacher pay does not match the level of education, responsibility, or workload required. When compared to other professions with similar qualifications, teaching often ranks lower in terms of financial reward. This gap discourages high-performing graduates from pursuing teaching careers and pushes current educators to seek better-paying opportunities elsewhere. Without competitive compensation, attracting and retaining qualified teachers becomes a continual struggle for education systems.

Limited Career Progression Opportunities

Many teachers report feeling stuck in their roles due to a lack of clear and rewarding career advancement paths. Unlike other professions where growth is linked to skill development and experience, teaching often lacks structured opportunities for promotion beyond administrative roles. This absence of professional growth options reduces motivation and satisfaction, especially for those who want to remain in classroom teaching while progressing in their careers. The lack of recognition for accomplished teaching further contributes to early exits from the profession.

Geographic and Subject-Specific Shortages

Recruitment and retention challenges are especially pronounced in rural areas and in specific subject fields such as mathematics, science, and special education. Teachers may be unwilling to relocate to remote areas with fewer amenities, limited housing, and social isolation. Moreover, schools in these locations often struggle to provide adequate support, which leads to faster burnout and turnover. Similarly, individuals with qualifications in high-demand subjects often find better-paying opportunities outside of education, making it harder to attract and keep them in teaching roles.

Lack of Support for Early-Career Teachers

New teachers often face overwhelming responsibilities without sufficient mentoring or structured induction programs. The first few years of teaching are typically the most challenging, and without proper guidance, many early-career teachers experience stress, isolation, and low confidence. The absence of strong support networks during this critical period contributes to high attrition rates. Studies have shown that schools with strong mentoring and induction programs have much higher teacher retention rates, highlighting the importance of investing in early-career support systems. This challenges such as poor working conditions, inadequate pay, limited career growth, geographic and subject shortages, and lack of support for new teachers continue to undermine efforts to build a stable and effective teaching workforce. Addressing these issues through focused policies and practical strategies is essential to strengthening teacher recruitment and retention.

Pre-Service Teacher Preparation Programs

Pre-service teacher preparation programs play a foundational role in shaping the quality and effectiveness of future educators. These programs are designed to equip aspiring teachers with the knowledge, skills, and professional dispositions required to succeed in diverse classroom environments. A well-structured teacher preparation program not only enhances instructional quality but also influences teacher retention, especially during the early years of teaching. When teacher candidates are adequately prepared before entering the profession, they are more confident, capable, and likely to remain in their roles long-term.

Furthermore, pre-service programs that offer a blend of theoretical knowledge and practical experience produce more competent and resilient teachers. A major component of effective programs is early and continuous field experience. This includes classroom observations, practicum placements, and student teaching under the supervision of experienced mentors. These experiences help candidates connect theory to practice, understand the realities of teaching, and develop classroom management strategies. According to Zeichner (2010), preservice teachers who engage in extensive clinical practice during their training are more effective in their first years and demonstrate higher levels of job satisfaction.

Moreover, the quality of teacher preparation is influenced by the curriculum and faculty expertise within training institutions. Programs that focus on subject matter content, pedagogy, assessment strategies, and inclusive education better prepare candidates to address the diverse needs of learners. Additionally, preparing teachers to work in high-need settings such as rural schools or schools with high populations of English language learners requires specialized training that some programs are now incorporating. These tailored components help ensure that new teachers are not only ready to teach but also to thrive in challenging educational environments.

The structure and duration of teacher education programs significantly impact teacher readiness. Fast-track certification routes, while designed to address teacher shortages quickly, often provide limited preparation time, leaving new teachers feeling underprepared. In contrast, traditional or residency-based models, which involve immersive, year-long placements in schools, are more effective at preparing teachers for long-term success (Guha, Hyler, & Darling-Hammond, 2016). These models promote collaboration, mentorship, and a gradual assumption of responsibilities, giving candidates the opportunity to build competence and confidence.

Although many programs provide a strong foundation, disparities in quality still exist across teacher preparation institutions. Some candidates graduate with minimal exposure to real-world classroom challenges, while others benefit from comprehensive, research-based training. To address these inconsistencies, policymakers and accrediting bodies have begun to emphasize the importance of standardization, accountability, and continuous improvement in teacher education. Institutions are increasingly being held responsible for demonstrating the effectiveness of their graduates in the classroom through data on student outcomes, teacher retention rates, and feedback from school administrators.

Also partnerships between universities and K-12 schools are essential for strengthening pre-service training. School-university collaborations ensure that teacher preparation remains relevant to current classroom realities and allows candidates to learn within authentic, supportive environments. These partnerships also help align expectations between training institutions and employers, making it easier for new teachers to transition from student to professional. Preservice teacher preparation programs are a critical foundation for teacher quality and retention.

Programs that integrate rigorous coursework, meaningful field experiences, and strong mentorship produce educators who are well-equipped to meet the demands of the profession. Ensuring consistency, depth, and practical relevance in teacher education is essential to building a strong, stable, and effective teaching workforce.

Professional Development and Continuous Learning

In the dynamic landscape of education, the quality of teaching stands as a paramount determinant of student success. Central to fostering this quality is the commitment to continuous professional development (CPD) and lifelong learning for educators. This approach not only enhances teaching practices but also addresses the critical issue of teacher retention, ensuring a stable and effective educational environment. Professional development encompasses a broad spectrum of activities aimed at enhancing teachers' skills, knowledge, and effectiveness. It extends beyond initial training, offering ongoing opportunities for educators to engage in learning experiences that promote reflective practice, collaboration, and the adoption of innovative teaching strategies. High-quality CPD programs are characterized by their relevance to teachers' needs, active learning methodologies, and sustained engagement over time (Education Policy Institute, 2021).

Engaging in continuous learning enables teachers to stay abreast of the latest pedagogical research, technological advancements, and curriculum changes. This up-to-date knowledge empowers educators to implement evidence-based practices that cater to diverse student needs. Moreover, CPD fosters a culture of reflective practice, encouraging teachers to critically assess and refine their instructional methods. Such professional growth directly correlates with improved student outcomes, as teachers apply enhanced strategies to facilitate deeper learning experiences.

The relationship between professional development and teacher retention is well-documented. Educators who perceive opportunities for growth and advancement are more likely to remain in the profession. CPD initiatives that offer personalized learning paths, mentorship, and leadership development contribute to job satisfaction and a sense of professional fulfillment. Conversely, the absence of such opportunities can lead to burnout and attrition, particularly among early-career teachers (Association of Colleges, 2024). Effective CPD programs share several key characteristics:

- Alignment with Teacher Needs: Tailoring development opportunities to address the specific challenges and interests of educators ensures relevance and engagement.
- Active Learning: Incorporating hands-on activities, collaborative projects, and peer observations promotes deeper understanding and skill acquisition.
- Sustained Engagement: Ongoing support through coaching, follow-up sessions, and reflective practices reinforces learning and facilitates long-term application.
- Leadership Opportunities: Providing avenues for teachers to take on leadership roles within CPD initiatives fosters a sense of ownership and professional growth.

Despite its benefits, the implementation of effective CPD faces challenges, including limited time, resources, and institutional support. Additionally, ensuring equitable access to high-quality professional development across diverse educational settings remains a significant concern. Addressing these barriers requires a concerted effort from educational policymakers, school leaders, and communities to prioritize and invest in teacher development. Continuous

professional development is not merely a supplementary aspect of teaching; it is integral to the enhancement of teacher quality and the retention of skilled educators. By fostering a culture of lifelong learning, educational systems can empower teachers to meet the dynamic needs of students, thereby improving educational outcomes and ensuring a sustainable and effective teaching workforce.

Workload and Time Allocation

Excessive workloads are a common grievance among teachers globally. Administrative tasks, testing requirements, and extracurricular obligations often encroach on the time teachers can dedicate to lesson planning, collaboration, and student engagement. When teachers are overwhelmed by bureaucratic demands and insufficient instructional support, their professional identity may suffer, leading to emotional exhaustion and reduced efficacy (Buchanan, 2010). Creating time within the school day for meaningful planning, peer observation, and collaboration is essential for fostering a sense of professional agency and reducing stress.

Autonomy and Decision-Making

Teacher autonomy the ability to make instructional and curricular decisions is another critical aspect of a healthy work environment. Teachers who feel trusted and empowered to tailor their teaching to the needs of their students report higher job satisfaction and commitment to their school. Conversely, overly prescriptive curriculum mandates and micromanagement by administrators can diminish teachers' sense of professional efficacy and innovation. Autonomy also includes participation in school decision-making processes. Schools that involve teachers in governance, policy formulation, and leadership roles create a culture of shared responsibility and investment, which is strongly associated with higher retention rates and improved student outcomes (Johnson et al., 2012).

Among all working condition variables, school leadership is arguably the most influential. Principals and school leaders shape the instructional climate, manage organizational structure, resolve conflicts, and support teacher development. Effective leadership directly contributes to improved student achievement and teacher satisfaction (Leithwood et al., 2004).

Strong school leaders do more than manage logistics; they serve as instructional leaders who mentor staff, facilitate professional learning communities, and foster a shared vision of excellence. According to research by Kraft et al. (2016), teachers who rate their school leadership highly are significantly less likely to leave their schools. Furthermore, schools with high leadership quality often have more coherent instructional programs, better collaboration among staff, and a stronger focus on continuous improvement.

Leadership and Mentorship for New Teachers

Effective induction and mentorship programs typically overseen or supported by school leaders are vital for novice teacher retention. New teachers often cite lack of support as a primary reason for leaving the profession within their first five years (Darling-Hammond et al., 2017). Principals who actively pair novice teachers with experienced mentors, conduct regular check-ins, and provide constructive feedback create a culture of growth and resilience. Leadership practices that promote psychological safety, professional dialogue, and recognition also contribute to a positive

school culture where teachers feel respected and motivated. Schools that lack such leadership often see higher attrition, particularly among teachers working in high-need environments.

It is important to recognize that poor working conditions disproportionately affect schools serving low-income and minority communities. Teachers in these schools often face larger class sizes, outdated materials, and higher rates of student trauma and behavioral challenges, yet receive less support (Carver-Thomas & Darling-Hammond, 2017). Without targeted policy interventions to improve working conditions in such schools, these disparities contribute to chronic staffing shortages and lower student achievement in already marginalized populations. Policy solutions must focus on providing additional resources, administrative support, and incentives for school leaders to prioritize working conditions in high-need settings. Funding should also be allocated for building upgrades, smaller class sizes, and specialized staff (e.g., counselors, instructional coaches) to alleviate teacher burdens. Improving working conditions and strengthening school leadership are foundational to building and sustaining a high-quality teaching workforce. While compensation, professional development, and incentives are critical, they must be complemented by environments where teachers feel safe, supported, and professionally respected. School leaders are uniquely positioned to influence these conditions and drive systemic improvement. Prioritizing leadership development and teachercentered policies, educational systems can significantly improve retention, morale, and ultimately student outcomes.

Community and Stakeholder Engagement

Engaging communities and stakeholders in the education system is a vital but often underutilized component of improving teacher quality and retention. Schools do not operate in a vacuum; rather, they are embedded in a social ecosystem that includes families, community organizations, policymakers, local businesses, and higher education institutions. Effective engagement with these actors can foster supportive teaching environments, enhance student learning outcomes, and create sustainable networks that bolster teacher morale and career commitment. Policy interventions that promote community and stakeholder involvement have proven instrumental in building trust, providing resources, and developing culturally responsive educational settings that are conducive to both teacher and student success.

Stakeholder engagement refers to the meaningful inclusion of individuals and groups who are invested in the outcomes of the education system. These stakeholders may include parents, guardians, community leaders, non-governmental organizations, business leaders, policymakers, school boards, and higher education institutions. Engagement is not merely consultative; it involves a collaborative process where stakeholders participate in planning, decision-making, implementation, and evaluation of school policies and practices (Epstein, 2011).

Community engagement, a subset of stakeholder involvement, refers specifically to the partnerships between schools and the communities in which they are located. These partnerships can take many forms volunteering, mentoring programs, after-school initiatives, resource donations, and local advocacy campaigns. When successfully integrated into educational planning, these relationships can alleviate pressure on teachers, provide additional support for students, and help align school goals with local values and needs.

Teachers working in such environments report higher levels of professional satisfaction, lower levels of isolation, and a greater sense of shared responsibility (Bryk et al., 2010). These

factors are critical in mitigating burnout, especially in schools serving disadvantaged populations, where teachers often face greater instructional and emotional demands. Moreover, stakeholder engagement can help reduce the external stressors that affect student behavior and learning, which in turn eases classroom management burdens for teachers. For example, partnerships with social service agencies can provide mental health support, nutritional assistance, and housing stability to students and their family's services that significantly influence classroom dynamics and teacher workload (Ishimaru, 2014).

Community partnerships also contribute to teachers' sense of purpose and connection to the broader mission of public education. Teachers who perceive their work as impactful and appreciated by their community are more likely to remain in the profession (Gu & Day, 2013). This is especially important in rural and urban schools, where high turnover often correlates with a lack of community connection and professional isolation.

Culturally responsive engagement is particularly important in diverse and multicultural school contexts. Teachers are more effective and feel more confident when they are supported in understanding and embracing the cultural backgrounds of their students. Community engagement can serve as a bridge, helping teachers connect with students' families, languages, histories, and lived experiences. These connections make the curriculum more relevant and increase teacher efficacy (Gay, 2018).

When schools value the cultural capital of their communities and reflect this in their pedagogy, teacher-student relationships improve, leading to better classroom climate and job satisfaction for educators. Teachers working in culturally inclusive environments report higher engagement and a stronger commitment to equity and social justice in their practice, which are linked to professional motivation and long-term retention (Villegas & Lucas, 2007).

Several national and international education policies advocate for greater stakeholder involvement. For example, the Every Student Succeeds Act (ESSA) in the United States mandates that states and districts engage families and community partners in the development of education plans. Such policies recognize that systemic improvement is only possible through collaboration. Internationally, the Organisation for Economic Co-operation and Development (OECD) has emphasized the role of social capital in school improvement. Countries that institutionalize stakeholder participation such as Finland and Canada report higher teacher satisfaction and more equitable student outcomes (OECD, 2020). These examples suggest that sustained policy commitment to community engagement is a key driver of both teacher effectiveness and retention.

Community and stakeholder engagement is not an auxiliary component of school improvement it is central to fostering an environment in which teachers and students can thrive. Connecting schools to the social fabric of their communities, policy interventions can strengthen educational ecosystems, enhance teacher well-being, and promote long-term retention. For teacher quality reforms to be successful and sustainable, they must be embedded in inclusive, collaborative practices that reflect the voices and assets of the entire educational community. Schools flourish when teachers feel supported not only by administrators and colleagues but by the broader community that shares in the mission of education.

Evaluating the Impact of Policy Interventions

Policy interventions targeting teacher quality and retention have become central to education reform agendas worldwide. These initiatives range from professional development programs and

compensation incentives to leadership training and improved working conditions. However, implementing policies without rigorous evaluation can result in wasted resources, missed opportunities, and unintended consequences. Evaluation is not only necessary to determine the effectiveness of these interventions but also to inform future policy design, enhance accountability, and ensure that reforms achieve intended goals in a sustainable and equitable manner.

Educational policies, particularly those affecting teachers, operate in complex systems influenced by a variety of sociopolitical, economic, and institutional factors. Evaluating these policies allows stakeholders to determine what works, for whom, under what conditions, and why. Without data-driven assessment, decision-makers risk perpetuating ineffective practices or failing to scale successful ones.

Policy evaluation is critical to ensuring that investments in teacher recruitment, preparation, support, and retention yield measurable improvements. For instance, governments often allocate substantial funds to incentive schemes or training programs with the expectation of reducing turnover or raising instructional quality. If these programs are not systematically evaluated, it becomes difficult to justify their continuation or modification (Levin, 2013). Furthermore, evaluation supports transparency, enabling policymakers to demonstrate the impact of reforms to taxpayers, educators, and other stakeholders.

A well-known example of policy evaluation in teacher retention is the Tap System (Teacher Advancement Program) in the United States. The program, which includes performance-based bonuses, career ladders, and ongoing professional development, was evaluated through a combination of longitudinal student data and teacher surveys. Results showed positive impacts on teacher retention and student achievement in participating schools (Springer et al., 2012).

Another example is the impact evaluation system in Washington, D C, which rigorously evaluated teacher performance using classroom observations, student achievement, and value-added measures. Teachers rated as highly effective received significant bonuses and retention incentives. A study found that IMPACT improved teacher performance and retention of top performers while encouraging voluntary exit among low performers (Dee & Wyckoff, 2015). These examples illustrate the value of combining data on outcomes, implementation fidelity, and teacher perceptions to draw meaningful conclusions about policy effectiveness.

CONCLUSION

Policy interventions aimed at enhancing teacher quality and retention two crucial pillars of educational success. Through an examination of teacher preparation, professional development, compensation, working conditions, school leadership, community engagement, and evaluation mechanisms. It also emphasized that improving teacher quality and reducing attrition require comprehensive, systemic, and sustained efforts. It highlighted that effective policies must be evidence-based, equity-focused, and contextually relevant. Furthermore, involving stakeholders, ensuring supportive leadership, and creating professional pathways for growth are essential for building a resilient and motivated teaching workforce. Moving forward, policymakers must prioritize teacher-centered reforms that not only attract new talent but also foster the professional well-being and long-term commitment of existing educators. Strengthening the teaching profession ultimately leads to improved student outcomes and a more equitable and effective education system.

Suggestions

Suggestions for future policy directions aimed at improving teacher quality and retention, below are several suggestions which are:

- Policies makers should focus on creating structured, sustained professional development systems that support teachers at all stages of their careers from induction to mastery.
- Government should ensure that teacher's education programs equip candidates with practical classroom experience, content knowledge, and culturally responsive pedagogical skills.
- New teachers should be supported through structured induction programs that include mentorship and reduced teaching loads.
- Policymakers should address the misdistribution of qualified teachers, especially in rural, low-income, and high-minority schools.
- Educational leaders should aim to professionalize teaching by offering competitive salaries, benefits, and career advancement opportunities (e.g., lead teacher roles, instructional coaching).
- School leaders should be trained to foster positive working conditions, support teacher collaboration, and engage in shared decision-making with teachers and communities.
