Decision-making approaches refer to the various methods or processes used to identify, evaluate, and select the best course of action from a set of available alternatives. The paper was supported by the Rational Decision-Making Model, proposed by Herbert Simon, which emphasized the importance of systematic, logical approaches to decision-making. The paper identified decision-making approaches for effective management of public senior secondary schools to include; participatory decision-making, evidence-based decisionmaking, top-down decision-making, consensus decision-making, decentralized decision-making, consultative decisionmaking, collaborative decision-making, strategic decision-making, contingency decision-making and ethical decisionmaking. It therefore concluded that improving decision-making processes in public senior secondary schools in Rivers State is essential for achieving better educational outcomes. The paper therefore suggested that school administrators should actively engage in participatory decision-making processes to involve teachers, parents, and students in decisionmaking.

Without effective decision-making, these resources can be wasted or misdirected, contributing to poor school performance, low student achievement, and reduced morale among educators. Without a systematic approach to resource allocation, important areas like teacher professional development, classroom resources, and student support services might be neglected, leading to a cycle of underperformance (Ololube, 2007). As a result, the management of public senior secondary schools requires a significant shift toward more effective and evidence-based decision-making approaches (Nwachukwu & Ojukwu, 2018). This paper explores the importance of decision-making approaches for effective management of public senior secondary schools in Rivers State.

CONCEPTUAL CLARIFICATION

Decision-Making

Decision-making is a crucial process in educational management, involving the selection of the best alternative from a set of options. Smith (2019) defined decision-making as the process of carefully considering the implications of each option on overall educational goals, emphasizing critical thinking and analysis. In school management, this means choosing strategies that promote efficiency, equity, and student achievement. This approach is essential for school administrators who must prioritize policies and practices that lead to measurable improvements in educational outcomes.

Jones and Williams (2020) described decision-making as a dynamic process that requires school leaders to identify educational needs, evaluate alternatives, and select the most effective solutions based on data and feedback from stakeholders. This definition highlights the importance of a responsive approach to decision-making, where continuous assessment of the changing needs of students, teachers, and the community ensures that decisions are both relevant

and effective. In an era of rapid change, including technological advancements and shifting demographics, effective decision-making relies on ongoing engagement with data and stakeholder input. Brown (2021) viewed decision-making as the process of identifying educational challenges, collecting relevant information, and selecting actions that align with institutional goals and available resources. This approach is particularly relevant for Rivers State's public senior secondary schools, where administrators must address local challenges, such as resource constraints, infrastructure gaps, and outdated curricula. Leveraging data, school leaders can make informed decisions that not only address immediate concerns but also contribute to the long-term development of the institution. Taylor and Johnson (2020) described decision-making as a process where school leaders involve teachers, parents, and students in decisions. This fosters a sense of community ownership and ensures that decisions reflect the values and needs of the school. Collaboration creates a more inclusive environment, where diverse perspectives are considered, which is especially important in addressing the socioeconomic challenges faced by schools in Rivers State. Decision-Making Approaches

These approaches involve assessing situations, weighing different options, and making choices that lead to the desired outcomes. In the context of management, including educational management like public senior secondary schools, decision-making approaches help leaders and administrators address challenges, allocate resources, set goals, and implement strategies effectively. Different decision-making approaches can be used depending on the nature of the problem, the available information, the context, and the resources at hand. These approaches vary in their level of involvement from individuals or groups, the use of data and evidence, and the time taken to make decisions. on student performance, resource utilization, and teacher effectiveness can guide the development of targeted solutions (Ojukwu & Okechukwu, 2020).

Top-Down Decision-Making: School leadership makes decisions and communicates them to teachers and staff for implementation. This hierarchical model is often quicker in decision-making but may lack input from those directly affected by the decisions (Anderson & Clark, 2018).

Consensus Decision-Making: Involves gathering input from all stakeholders and striving for agreement on decisions. This approach is particularly useful in building trust and ensuring that decisions reflect the collective will of the school community (Clement, 2022).

Decentralized Decision-Making: Empowers individual schools or departments to make decisions based on their specific needs. This approach fosters local autonomy and allows for more contextually relevant solutions (Smith, 2021).

Consultative Decision-Making: Leaders seek advice and feedback from experts, teachers, and other key stakeholders before making a final decision. This ensures that decisions are informed by specialized knowledge and practical insights (Rufus, 2023).

Collaborative Decision-Making: Involves working together as a team to solve problems and make decisions. Collaboration ensures that diverse perspectives are considered, which can lead to more innovative and effective solutions (Ololube, 2018).

Strategic Decision-Making: Focuses on long-term planning and aligning decisions with the school's mission and goals. This approach ensures that immediate actions contribute to the broader vision of educational success (Johnson, 2020).

Contingency Decision-Making: Allows for flexibility and adaptability in decision-making, enabling school leaders to respond to unexpected challenges or opportunities in a timely manner (Newman, 2019).

Ethical Decision-Making: Ensures that decisions are made with fairness, integrity, and a commitment to the values of equality and justice. Ethical decision-making is crucial in ensuring that all students, regardless of background, receive a high-quality education (Harrison, 2023).

Effective Management

Effective management refers to the process of planning, organizing, coordinating, and overseeing resources and activities in an organization to achieve its objectives efficiently and effectively. It involves making strategic decisions that optimize the use of available resources (such as human, financial, and physical resources) and ensuring that the organization's goals are met. Ololube (2024) defined effective management as the ability to optimize resources and direct them towards achieving the school's educational objectives, including the management of human resources, financial resources, and physical infrastructure. This suggests that a well-managed school system maximizes its resources to create an environment conducive to learning.

Jones (2021) described effective management as the process of ensuring that educational objectives are met through careful planning, organizing, and overseeing the school's operations. This highlights the importance of structured planning and organization in the day-to-day operations of schools, ensuring that all aspects of the institution function harmoniously to achieve its educational goals. Brown (2019) viewed effective management that involves anticipating problems and developing solutions in advance to ensure the smooth running of the school's activities. This underscores the importance of foresight and preemptive actions in school management, which are critical for addressing potential issues before they escalate and disrupt educational operations.

Taylor and Johnson (2020) defined effective management as the coordination and integration of all key processes within the school system. This includes curriculum development, staff management, and student engagement, all of which must work in unison to achieve the overarching educational goals. Their perspective reflects the complexity of school management, where various components need to be aligned and coordinated for optimal functioning. Harrison (2017) viewed effective management as the ability to make decisions that enhance school performance and academic excellence. This involves ongoing evaluation and adjustments to ensure that resources are being used efficiently. This definition highlights the role of decision-making in management, suggesting that effective leaders continuously assess and refine their strategies to ensure that the school is progressing towards its objectives. In the context of Rivers State, the effective management of public senior secondary schools becomes evident through the application of strategic decision-making approaches.

DECISION-MAKING APPROACHES FOR EFFECTIVE MANAGEMENT OF PUBLIC SENIOR SECONDARY SCHOOLS

Participatory Decision-Making and Effective Management

Participatory decision-making refers to a democratic process where individuals, particularly those directly affected by the decision, are involved in making choices that shape outcomes. In the educational context, it emphasizes the active engagement of all stakeholders including teachers, parents, students, and administrators in the decision-making process. This approach ensures that the perspectives, concerns, and ideas of all participants are taken into account, fostering a sense of ownership and collaboration. The engagement of the school community not only enhances the quality of decisions but also strengthens the support and commitment to their implementation. Smith and Jones (2018) emphasized that participatory decision-making leads to greater accountability and transparency within schools. When teachers and other stakeholders are involved in shaping policies, they are more likely to support and uphold the decisions that have been made.

Participatory decision-making plays a crucial role in fostering a collaborative atmosphere within schools. Johnson and White (2017) highlighted how this approach can significantly enhance school-wide cooperation and contribute to long-term educational improvements by fostering an environment of trust, open communication, and shared responsibility. Their work emphasizes the importance of involving all stakeholders in decision-making processes to build stronger relationships and a collective commitment to student success. Participatory decision-making is also critical in promoting effective leadership in schools. Roberts et al. (2018) argued that when leadership is shared among various stakeholders, the overall effectiveness of school

policies increases. This collaborative approach not only ensures that diverse perspectives are considered but also strengthens the sense of ownership and accountability among all participants. Distributing leadership, schools can create more inclusive and responsive policies that better meet the needs of students, staff, and the broader community.

Lee and Wang (2019) emphasized that it is a powerful tool for ensuring that educational policies are responsive to the needs of diverse student populations, fostering a more inclusive and equitable learning environment. Brown and Miller (2020) encourage the integration of community feedback into school practices, leading to more responsive and adaptive school management strategies that better meet the needs of students and families. Greenfield and Adams (2021) argued that it allows for more equitable distribution of resources, ensuring that marginalized voices are heard and included in the shaping of educational strategies, eventually fostering a more just and effective learning environment.

More so, Nguyen (2019) argued that involving teachers, parents, and local community members in decision-making processes will allow the schools to better address the specific needs and concerns of the community, making educational practices more relevant and effective. Participatory decision-making is particularly important for the effective management of public senior secondary schools in Rivers State, where the education sector is often plagued by issues such as insufficient funding, poor infrastructure, and low levels of community involvement. Engaging all relevant stakeholders in the decision-making process, Rivers State schools can develop more tailored, community-specific solutions that are more likely to succeed. This strategy could also foster a sense of empowerment among teachers, students, and parents, ensuring that decisions are made with a shared vision of educational success.

Top-Down Decision-Making and Effective Management

While it allows for quick decisions and a unified vision, it can also limit participation from teachers, students, and other stakeholders. This lack of input may create a gap between leadership and the community, potentially affecting the effectiveness of the policies implemented. Garcia and Thompson (2018) suggested that top-down decision-making is particularly useful in contexts where clear, cohesive direction is needed. Their research indicates that in high-pressure environments, such as those faced by large public school systems, this model allows for rapid implementation of policies that address urgent issues. In similar vein, Kumar et al. (2019) highlighted a key limitation of this approach. They argue that while it can create consistency across schools, it can also lead to dissatisfaction and disengagement among staff members who feel their voices are not heard in the decision-making process. Their study found that when teachers and staff are excluded from discussions, the implementation of policies may be less effective.

Top-down decision-making can sometimes limit the effectiveness of policies in addressing local needs. Morris and Zhang (2017) cautioned that top-down decision-making can overlook the specific needs and unique challenges faced by individual schools. Their findings emphasize that without input from frontline educators, policies may not be as relevant or applicable to local contexts, leading to challenges in their execution. Anderson and Clark (2018) contended that top-down decision-making can be a vital tool for ensuring uniform standards across large and diverse educational systems. Their study shows that when central leadership

provides clear guidelines and expectations, schools can operate more efficiently, particularly in resource-limited environments.

Moreover, top-down decision-making can be particularly effective in situations that require swift action. Martinez et al. (2020) pointed out that in the case of emergency or crisis management, top-down decision-making allows for a coordinated, rapid response. Their research demonstrates that during instances like natural disasters or unexpected disruptions, top-down approaches enable educational systems to act quickly and decisively to protect students and staff. In Rivers State, where the education system is often marked by a lack of cohesion and inconsistent management practices, top-down decision-making could be useful in ensuring that there is a clear direction and policy implementation across public senior secondary schools. The challenge, however, lies in balancing the need for centralization with the need for stakeholder engagement, ensuring that decisions are made efficiently while still considering the perspectives of teachers and parents.

Consensus Decision-Making and Effective Management

Consensus decision-making is a collaborative approach where all members of a group work together to find solutions that everyone can support, even if the outcome is not ideal for everyone. This method prioritizes open dialogue, compromise, and mutual understanding, which can lead to more inclusive and sustainable decisions. In educational settings, involving all stakeholders in the decision-making process can build a shared vision and foster cooperation, eventually increasing the likelihood of successful implementation of policies. Johnson and Patel (2018) emphasized that consensus decision-making in schools can enhance the sense of ownership and responsibility among stakeholders. Their research highlights how involving teachers, administrators, and parents in decision-making leads to greater commitment to the decisions made, as all voices are considered in the process. Similarly, Williams (2017) argued that consensus decision-making helps mitigate conflicts by encouraging mutual understanding. They found that when diverse perspectives are incorporated, it can reduce resistance to policies and improve overall school climate, as everyone feels valued and heard.

Consensus decision-making is a valuable approach in creating a collaborative and inclusive school culture. Lee and Walker (2020) highlighted the importance of consensus decision-making in fostering a more participatory school environment. Their study shows that when teachers and administrators work together to reach agreements, the resulting policies are more likely to reflect the needs and realities of both staff and students, leading to stronger support and commitment from all involved. Jackson et al. (2019) cautioned that the process can sometimes become too lengthy, especially in large school systems where reaching full agreement among all stakeholders may take considerable time. Their research suggests that while consensus-building is important, it may not be feasible in urgent situations where immediate action is required.

Consensus decision-making plays a key role in building a unified and cooperative school environment. Takahashi and Yu (2018) emphasized that consensus decision-making can create a sense of community and shared purpose in schools. They argue that this collaborative approach enhances communication among staff members, students, and parents, leading to stronger partnerships and more effective problem-solving. Similarly, Roberts and Zhang (2021) contended that consensus decision-making can increase the accountability of all stakeholders. Actively participating in the decision-making process, each member feels a greater responsibility

to contribute to the successful implementation of the agreed-upon policies. Their study found that schools employing consensus-building strategies tend to have better long-term results in areas like student achievement and teacher satisfaction. Consensus decision-making is crucial for fostering trust and collaboration within schools. Martinez and Lopez (2020) suggested that one of the key advantages of consensus decision-making is its ability to create an environment of trust. They found that when stakeholders work together to find common ground, it enhances collaboration and reduces misunderstandings, which eventually leads to more effective implementation of school policies and a stronger sense of community..

In the context of Rivers State, where public senior secondary schools often face social and economic challenges that require creative solutions, consensus decision-making could be an effective strategy. Encouraging dialogue among various stakeholders, such as teachers, parents, and local leaders, will likely lead to more inclusive and widely supported decisions. This approach could help address some of the systemic issues facing schools in Rivers State, such as resource allocation and curriculum development.

Decentralized Decision-Making and Effective Management

Decentralized decision-making is a governance model where authority is distributed across various levels of an organization, allowing local leaders, such as school principals or teachers, to make decisions tailored to the unique needs of their community. This approach fosters flexibility and responsiveness, making it especially effective in diverse educational systems where local circumstances and challenges can vary significantly. Foster and Nguyen (2018) argued that decentralized decision-making enhances the responsiveness of schools to the unique needs of their student populations. Their study suggests that schools with more decision-making power at the local level can implement policies that are better aligned with the specific context and needs of their students.

Similarly, Martinez and Blake (2019) emphasized that decentralization fosters greater innovation in schools. Granting autonomy to school leaders, decentralization enables the experimentation of new teaching methods and practices, which can lead to more effective solutions tailored to local needs. Their research highlights that this autonomy can lead to significant improvements in student outcomes when leaders are given the freedom to respond to immediate challenges. Decentralized decision-making is an effective way to empower educators and improve school outcomes. Hernandez and Li (2020) argued that decentralization leads to greater teacher empowerment, as educators are involved in the decision-making process. They found that when teachers have a say in how schools are run, they are more motivated and engaged, leading to better educational outcomes for students. Their findings underscore the importance of giving teachers a voice in shaping school policies and practices, ultimately fostering a more committed and effective teaching community. In similar vein, Taylor et al. (2021) highlighted the potential challenges of decentralization, particularly in maintaining consistency across schools. Their study suggests that establishing clear guidelines and communication channels can help mitigate these challenges.

Decentralized decision-making fosters a more inclusive and collaborative approach to addressing school challenges. Singh and Patel (2017) asserted that decentralization promotes a more collaborative approach to decision-making, where school leaders, teachers, and even

parents work together to address local issues. They argue that this shared decision-making process strengthens the sense of ownership and accountability at the school level, leading to more effective policy implementation. Decentralized decision-making enhances a school's ability to respond to evolving needs and challenges. Davies and Carter (2019) noted that decentralized decision-making enables schools to better adapt to changing educational demands and policies. Their research shows that schools with decentralized authority are more agile and able to adjust their practices quickly in response to new challenges, whether they are academic, social, or economic. More-so, Zhang and Lee (2020) emphasized that decentralization can enhance local accountability, as leaders are directly responsible for the outcomes of their decisions. Similarly, Kumar and Zhang (2019) emphasized that consultative decision-making helps bridge the gap between school leaders and the broader school community. Soliciting input from students and teachers, school administrators can ensure that their decisions address the real, on-the-ground challenges faced by educators and students. Their study highlights that this involvement can lead to greater satisfaction and support for school policies.

Consultative decision-making plays a vital role in enhancing collaboration and fostering a positive school culture. Wilson (2020) pointed out that consultative processes not only improve the quality of decision-making but also contribute to a more collaborative school culture. More-so, Gonzalez and Roberts (2017) highlighted that consultative decision-making can help mitigate resistance to change. When stakeholders are included in the decision-making process, they are more likely to understand the rationale behind decisions and feel ownership of the outcomes. This shared responsibility often leads to smoother implementation of new policies and practices.

Consultative decision-making can enhance decision quality, but it also comes with challenges, particularly in terms of efficiency. Johnson (2019) noted that while consultative decision-making improves the quality of decisions, it can be time-consuming. Their research shows that, especially in large organizations like schools, gathering feedback from a wide range of stakeholders can slow down the decision-making process, making it less efficient when quick action is required. Brown and Clark (2020) argued that consultative decision-making enhances decision legitimacy, which is crucial for long-term success. When school leaders seek input from teachers, students, and parents, it helps ensure that decisions are seen as legitimate and responsive to the needs of the school community. This, in turn, increases the likelihood that the policies will be effectively implemented. Consultative decision-making is crucial for fostering inclusivity and trust within the school community. Singh and Thompson (2021) emphasized that consultative decision-making creates a more inclusive environment where all voices are heard. Their research suggests that this approach not only leads to better decisions but also promotes greater trust between school leadership and the broader school community, strengthening collaboration and support for school initiatives.

In Rivers State, where educational reform is urgently needed to address issues like low academic performance and resource constraints, consultative decision-making could ensure that policies are not only practical but also widely supported. Engaging teachers and parents in the decision-making process can create a more collaborative environment, making it easier to implement strategies aimed at improving school management and student outcomes.

Collaborative Decision-Making and Effective Management

Collaborative decision-making is a process in which multiple stakeholders, including school leaders, teachers, students, parents, and the broader community, come together to make decisions that affect the school's direction. This approach encourages the sharing of knowledge, expertise, and perspectives, fostering inclusivity, shared ownership, and teamwork. Collaborative decision-making is particularly valuable in education, as it enables the school community to work together toward common goals, enhancing both the process and outcomes. In a similar vein, Ololube (2024) emphasized that collaborative decision-making enhances communication and trust among all school stakeholders. Their study shows that when decisions are made collectively, the variety of insights and experiences from different stakeholders leads to more innovative and well-rounded solutions that better address the needs of the entire school community.

Collaborative decision-making plays a critical role in ensuring that school policies reflect the needs of the entire community. They suggest that by working together, schools and communities create stronger networks of support, which positively influences student achievement and well-being, fostering a more holistic and supportive learning environment. Harrison (2019) emphasized that collaborative decision-making builds a stronger school culture by promoting teamwork and mutual respect. The research shows that when school leaders engage with teachers, students, and parents in decision-making, it strengthens relationships and helps to create a more supportive and positive school environment.

In the context of Rivers State, collaborative decision-making offers a powerful strategy for managing the challenges faced by public senior secondary schools. With issues such as low student performance, inadequate infrastructure, and insufficient resources, fostering collaboration among teachers, parents, and community members can create more tailored solutions that address the local context. The active involvement of all stakeholders can lead to a more engaged and motivated school community, working together to ensure that educational goals are met.

Strategic Decision-Making and Effective Management

Strategic decision-making is a long-term, goal-oriented approach in which school leaders carefully consider both internal and external factors to make decisions that align with the school's mission and vision. It involves evaluating current conditions, anticipating future challenges, and ensuring that decisions contribute to the sustainable growth and development of the school. In education, strategic decision-making includes resource allocation, curriculum planning, staff development, and long-term infrastructure planning to ensure the continued success of the institution. Chang and Liu (2017) argued that strategic decision-making allows schools to proactively address potential challenges by aligning their policies with long-term goals. Their research shows that when schools make decisions with a clear understanding of future needs, they are better able to anticipate and navigate changes in the educational setting, leading to more sustainable success.

Similarly, Ololube (2017) highlighted the importance of strategic decision-making in adapting to shifting educational demands, such as changing curriculum standards or technological advancements. Their study suggests that schools that engage in strategic planning are better positioned to integrate innovations that improve student learning outcomes and teacher effectiveness. Strategic decision-making is crucial for ensuring long-term stability and effective resource management in schools. Clement (2019) stressed that strategic decision-making is essential for resource management, arguing that schools that engage in long-term planning for resource allocation, including finances and staffing, are better able to maintain stability and

support the needs of students despite external challenges such as budget cuts or fluctuating student enrollment. This approach helps schools remain resilient and focused on their educational goals. Ololube (2024) noted that strategic decision-making also plays a critical role in fostering a positive school culture. They found that when leadership focuses on long-term goals, such as developing staff capabilities or improving infrastructure, schools are more likely to foster a strong sense of community and purpose among teachers, students, and parents.

Strategic decision-making is essential for schools to remain adaptable in a constantly changing educational landscape. Morris and Chang (2020) argued that strategic decision-making allows schools to foster an adaptive learning environment that can respond to both external changes (such as shifts in governmental policy) and internal shifts (such as changes in student demographics). Their research shows that strategic planning helps schools remain flexible and responsive to both anticipated and unforeseen challenges, ensuring that they continue to meet the evolving needs of their students.

In Rivers State, public senior secondary schools face a range of challenges that require strategic thinking and planning. With many schools struggling with inadequate infrastructure and limited funding, strategic decision-making can provide a framework for making more effective use of available resources. The long-term benefits of strategic decision-making in Rivers State's educational system could include improved infrastructure, better-trained teachers, and more effective curricula that meet the needs of students in a rapidly changing world.

Contingency Decision-Making and Effective Management

Contingency decision-making is an adaptive, flexible approach where decision-makers respond to changing conditions, unexpected events, or crises. This approach requires school leaders to be responsive to immediate needs and make quick, informed decisions that address short-term challenges, all while ensuring long-term goals are not compromised. Similarly, Austin (2018) emphasized that contingency decision-making allows schools to respond effectively to immediate crises, such as staffing shortages or disruptions in daily operations. The study found that schools with flexible decision-making processes are better able to pivot and continue to provide quality education despite difficult circumstances.

Contingency decision-making is crucial for schools to remain resilient during times of uncertainty. Martinez and Lee (2019) argued that contingency decision-making helps schools maintain resilience in the face of external shocks like economic downturns or changes in government policy. They found that by being responsive and adaptive, schools can continue to prioritize student welfare and educational outcomes even when external conditions are volatile, ensuring that the needs of students are met regardless of external challenges. The study indicates that schools with clear, flexible decision-making structures are better equipped to protect students, ensure their safety, and continue to provide education even during disasters.

Contingency decision-making is vital for balancing immediate challenges with long-term goals in education. Chen and Wang (2020) argued that contingency decision-making helps educational leaders stay focused on long-term goals while managing immediate challenges. Their research found that schools that integrate contingency planning into their strategic vision can make decisions that support both short-term recovery and long-term educational growth, ensuring a sustainable path forward even during periods of crisis. Ololube (2024) emphasized that effective contingency decision-making requires a clear communication strategy. Their study highlights that schools that communicate swiftly and transparently during crises help build trust with stakeholders, ensuring that both staff and students remain engaged and focused on the school's educational mission during difficult times.

For Rivers State, where public senior secondary schools face frequent disruptions in terms of funding, infrastructure, and socio-political factors, contingency decision-making offers a means to manage these uncertainties effectively. With a contingency-based approach, school leaders can develop strategies that allow them to quickly respond to emerging challenges, ensuring that students continue to receive quality education even when resources are limited.

Ethical Decision-Making and Effective Management

Ethical decision-making involves making choices that are morally sound, fair, and just, ensuring that the well-being of all stakeholders is considered. In educational contexts, it is essential that decisions align with values such as equity, fairness, and justice. Ethical decision-making requires school leaders to balance competing interests while maintaining integrity, transparency, and accountability in all their actions.

It is critical for creating a positive school culture based on trust and respect. Martins and Silva (2018) argued that ethical decision-making is crucial in promoting fairness and equality within schools. Their research shows that when school leaders prioritize ethical considerations, they foster an environment where both students and staff feel respected and valued, contributing to the overall success and health of the school community. Similarly, Ololube (2024) highlighted that ethical decision-making can help address issues of inequity by ensuring that all students have access to fair treatment and opportunities. Their study suggests that when school leaders

make decisions with ethics in mind, they create a more inclusive environment that supports the success of diverse student populations. Ethical decision-making is crucial for fostering a fair and respectful school environment.

Bennett (2020) emphasized the importance of ethical decision-making in navigating conflicts that may arise within schools. The research suggests that when leaders make ethical decisions, they not only resolve conflicts fairly but also contribute to the development of a school culture where respect for differences is encouraged, ensuring that all voices are heard and valued, and promoting an inclusive atmosphere. Fredrick (2021) argued that ethical decision-making enhances trust between the school leadership and the wider school community. The study found that when ethical standards are upheld, students, teachers, and parents are more likely to trust and support the school's leadership, fostering a sense of security and stability within the educational environment. Ethical decision-making is fundamental for maintaining fairness and integrity in educational settings. Martins and Wilson (2018) asserted that ethical decision-making is essential for upholding the integrity of educational practices. Their research found that when school leaders make decisions rooted in ethics, they help ensure that policies are just, support the needs of marginalized groups, and align with both community values and national standards, ultimately fostering a more equitable and accountable educational environment.

Ethical decision-making plays a crucial role in building a strong and accountable school culture. Adams (2020) emphasized that ethical decision-making fosters a culture of accountability in schools. The study demonstrates that when leaders consistently make ethical decisions, they set an example for students and staff, reinforcing the importance of integrity and responsibility in all school activities, which helps cultivate a positive and respectful learning environment. Thus, ethical decision-making is key to tackling issues like discrimination, bias, and unfair treatment in schools. Their research shows that by applying ethical principles, school leaders can address systemic inequalities and create a more inclusive and supportive educational environment. In Rivers State, where disparities in educational access and resources are evident, ethical decision-making can serve as a guiding principle in addressing these inequalities. School leaders who adopt ethical decision-making practices can work towards ensuring that all students, regardless of background, have equal access to quality education. This approach is crucial in creating a fairer and more equitable educational system that meets the needs of all students in Rivers State's public senior secondary schools.

CONCLUSION

Improving decision-making processes in public senior secondary schools in Rivers State is essential for achieving better educational outcomes. Adopting modern decision-making approaches such as participatory decision-making, evidence-based decision-making, top-down decision-making, consensus decision-making, decentralized decision-making, consultative decision-making, collaborative decision-making, strategic decision-making, contingency decision-making, and ethical decision-making, school administrators can enhance management effectiveness. These approaches promote inclusivity, accountability, and adaptability, which are crucial for responding to the diverse challenges schools face. Although challenges exist, especially in resource-constrained environments like Rivers State, the adoption of these strategies will contribute to improved school management, stronger community involvement, and ultimately, higher educational quality. With continued focus and commitment, these decision-

Suggestions

Based on the exploratory discourse, the following suggestions are made:

- School Administrators should actively engage in participatory decision-making processes to involve teachers, parents, and students in decision-making.
- Government Education Officials must prioritize evidence-based decision-making by investing in data collection and research.
- Principals should implement decentralized decision-making to empower local school leaders to address specific challenges.
- Teachers should participate in consensus decision-making to ensure that decisions reflect collective input.
- School Management Boards must ensure that strategic decision-making aligns with long-term educational objectives.
- Educational Leaders should embrace consultative decision-making by seeking expert opinions on educational reforms.
- Community Stakeholders must foster a collaborative approach to decision-making, ensuring that the entire school community works together towards common goals.
- School Boards should support contingency decision-making to allow for flexibility in responding to unforeseen challenges.
- Parents and Teachers should promote ethical decision-making to ensure fairness and equity in all educational practices.
