This empowerment leads to higher job satisfaction, reducing burnout and increasing commitment to teaching. However, with proper delegation, training, and support, the benefits outweigh the drawbacks. #### CONCEPTUAL UNDERPINNING

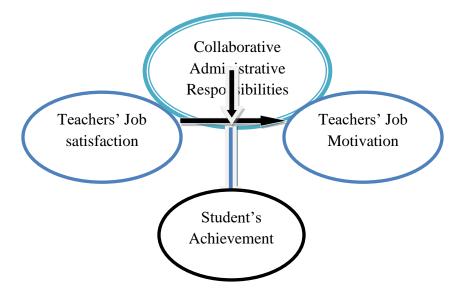


Figure 1: Concept of collaborative administrative responsibilities for teachers' job satisfaction, motivation and student's achievement

#### **Collaborative Administrative Responsibilities**

Collaborative administrative responsibilities in a school system involve the distribution of managerial, operational, and decision-making duties among various stakeholders, including school administrators, teachers, support staff, students, and community members. This approach enhances collaboration, improves efficiency, and fosters a sense of collective ownership in educational institutions. The traditional top-down model of school administration, where a single principal or a small group of administrators make all critical decisions, is increasingly being replaced by a more participatory approach. Schools can leverage diverse expertise, increase accountability, and improve overall institutional effectiveness by decentralizing decision-making (Bush, 2013).

The implementation of shared administrative responsibilities often involves various levels of participation, ranging from leadership teams to teacher-led committees and student councils. When decision-making is shared, teachers and staff feel more valued and engaged in the school's direction. This participatory leadership model fosters a culture of mutual respect and collaboration, creating a positive work environment and enhancing job satisfaction (Harris, 2014). Studies have shown that teachers who are involved in decision-making processes exhibit higher motivation and commitment to their work, leading to improved instructional quality and student outcomes (Leithwood & Azah, 2017).

#### **Teachers' Job Satisfaction**

It encompasses various elements such as working conditions, professional development opportunities, school leadership, workload, salary, and interpersonal relationships within the school environment. A high level of job satisfaction among teachers contributes to increased motivation, commitment, and retention, whereas dissatisfaction often results in burnout, absenteeism, and high turnover rates (Dinham & Scott, 2013). Understanding the determinants of job satisfaction is essential for creating supportive environments that enhance teacher performance and student learning outcomes.

The school climate which includes aspects such as collegial relationships, administrative support, and student behavior is one of the primary determinants of teachers' job satisfaction. A positive school climate fosters collaboration, respect, and professional growth, leading to higher job satisfaction. Skaalvik and Skaalvik (2018) suggested that teachers who experience supportive relationships with colleagues and administrators are more likely to remain in the profession and exhibit a strong sense of belonging. Conversely, a toxic work environment characterized by conflicts, lack of support, and disruptive student behavior can lead to stress and job dissatisfaction. Workload and administrative responsibilities significantly impact teachers' satisfaction levels. Excessive workload, including lesson planning, grading, extracurricular activities, and administrative tasks, often leads to stress and exhaustion. Studies carried out by Collie et al. (2012) indicated that teachers who perceive their workload as manageable report higher job satisfaction and better mental well-being. Schools that implement effective workload management strategies, such as providing teaching assistants and reducing non-teaching duties,

tend to have more satisfied teachers. Balancing workload ensures that educators can focus on instructional quality and student engagement without feeling overwhelmed.

Compensation and job security also play a vital role in determining teachers' job satisfaction. Competitive salaries, timely promotions, and job stability contribute to a sense of financial security and career fulfillment. Teachers who feel adequately compensated for their efforts are more likely to exhibit high morale and commitment to their profession (Ingersoll, Merrill, & Stuckey, 2014). However, low wages and a lack of career advancement opportunities often lead to frustration and attrition. Policymakers and school administrators must recognize the importance of fair compensation in retaining skilled educators and maintaining a motivated workforce. In addition, professional development opportunities are essential for enhancing teachers' job satisfaction. Continuous learning, skill enhancement programs, and career growth initiatives contribute to a sense of professional achievement. Desimone and Garet (2015) opined that teachers who engage in regular training and workshops feel more confident and effective in their roles, leading to increased job satisfaction. Moreover, mentorship programs and peer collaborations provide educators with the necessary support and guidance to navigate challenges in the teaching profession. Investing in professional development not only benefits teachers but also improves student learning experiences and educational outcomes.

School leadership and administration have a significant impact on teachers' job satisfaction. Effective leadership that values teachers' input, provides constructive feedback, and fosters a culture of respect and trust enhances job satisfaction. Principals and school administrators who exhibit supportive leadership styles, such as transformational and participatory leadership, create an environment where teachers feel valued and motivated (Leithwood et al., 2017). Conversely, autocratic or unsupportive leadership can lead to frustration, demotivation, and increased teacher turnover. Establishing strong leadership practices that prioritize teacher well-being is essential for maintaining a positive school culture. Student behavior and classroom management also influence teachers' job satisfaction. Educators who face frequent disciplinary challenges, disruptive behavior, and lack of parental support often experience stress and job dissatisfaction. Implementing effective classroom management strategies, promoting positive student-teacher relationships, and involving parents in disciplinary matters contribute to a more conducive learning environment (Marzano et al., 2015). Conversely, societies where teachers face low social status, inadequate resources, and frequent policy changes experience higher rates of teacher dissatisfaction (OECD, 2019).

#### Effects of Teachers' Job Dissatisfaction

When teachers experience dissatisfaction in their work, it often results in decreased motivation and engagement, which negatively affects the quality of education delivered to students. A lack of enthusiasm and commitment from teachers can lead to reduced student performance, as the learning environment becomes less stimulating and supportive. Job dissatisfaction among teachers contributes to high turnover rates, which disrupts the continuity of instruction and places additional strain on educational institutions to recruit and train new staff (Smith et al., 2018). Inadequate compensation and benefits are primary causes of job dissatisfaction among teachers. Many educators feel that their salaries do not reflect the demands and responsibilities of their roles, leading to frustration and financial stress. This issue is particularly prominent in underfunded schools, where resources are limited and teachers are expected to manage large class sizes with minimal support. Excessive workload and administrative responsibilities also contribute to dissatisfaction, as teachers find themselves overwhelmed with tasks beyond their core instructional duties (Johnson & Turner, 2021).

A lack of professional growth opportunities also fuels job dissatisfaction among teachers. When educators do not have access to continuous training, mentorship, and career advancement pathways, they may feel stagnant in their roles. The absence of professional development can lead to a decline in job satisfaction, as teachers struggle to stay motivated and innovative in their teaching practices. Moreover, workplace culture plays a crucial role in determining job satisfaction. Supportive leadership, collaborative work environments, and positive relationships with colleagues contribute to job fulfillment, while toxic workplace dynamics and lack of recognition can erode morale (Garcia & Lopez, 2020). It is noteworthy that chronic stress, burnout, and feelings of underappreciating can lead to mental health issues such as anxiety and depression. Prolonged dissatisfaction may also result in physical health problems, including fatigue and weakened immune function. As a result, absenteeism rates may increase, further affecting students' learning experiences and placing additional pressure on remaining staff members (Anderson, 2017).

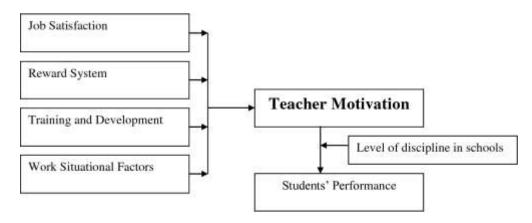
Teachers who experience job dissatisfaction often become less effective in their roles, which can directly affect student outcomes. A disengaged teacher may struggle to maintain classroom discipline, create engaging lesson plans, or provide meaningful feedback to students. Over time, this decline in teaching quality can contribute to lower student achievement levels, reducing overall educational standards. Students who do not receive the guidance and instruction they need may struggle with academic performance, leading to higher dropout rates and reduced future career prospects (Nguyen et al., 2019). Another major consequence of teacher dissatisfaction is the disruption caused by frequent staff turnover. High attrition rates among teachers create instability in schools, requiring constant recruitment and training of new staff. This cycle of hiring and losing teachers can be costly and time-consuming for educational institutions, diverting resources away from instructional improvements. Furthermore, students suffer when they must frequently adapt to new teachers, leading to inconsistencies in learning and difficulty in establishing strong teacher-student relationships. Williams and Carter (2022) opined that students benefit from long-term relationships with their educators, as continuity in teaching helps foster trust, stability, and effective learning environments.

The negative effects of teacher dissatisfaction are also evident in school culture and morale. When a significant portion of the teaching staff is unhappy with their working

conditions, it can create a toxic workplace environment. Dissatisfied teachers may withdraw from collaboration with colleagues, become resistant to new teaching methods, or express frustration in ways that affect their students. This negativity can spread throughout a school, affecting overall morale and decreasing motivation among other staff members. Conversely, a positive school culture that values teacher satisfaction and well-being can lead to a more cohesive and effective educational environment (Harrison & Lewis, 2020). Financial constraints also play a role in teacher dissatisfaction, particularly in schools with limited funding. Teachers in under-resourced schools often face challenges such as outdated materials, inadequate classroom supplies, and a lack of technological support. These obstacles make it difficult for educators to perform their duties effectively and can contribute to feelings of frustration and helplessness. Additionally, the disparity between schools with ample funding and those with fewer resources can lead to inequities in education, where students in low-income areas receive lower-quality instruction due to teacher dissatisfaction and burnout (Martinez et al., 2018).

One possible solution to addressing teacher dissatisfaction is implementing policies that improve working conditions and job satisfaction. Offering competitive salaries, reducing unnecessary administrative tasks, and providing meaningful professional development opportunities can help retain teachers and enhance their effectiveness. Additionally, fostering a positive school culture where teachers feel valued and supported can contribute to higher job satisfaction levels. Schools that prioritize teacher well-being are more likely to maintain a stable and motivated teaching workforce, which ultimately benefits students (Roberts & Kim, 2021). Teachers' job motivation in a Nigerian school system is a critical factor influencing the quality of education, teacher performance, and student outcomes. Motivation determines the level of commitment, enthusiasm, and perseverance teachers exhibit in their professional duties. Several factors impact teachers' motivation, including salary, working conditions, career advancement opportunities, school leadership, recognition, job security, and the socio-cultural environment.

Understanding these factors and implementing policies to enhance motivation is essential for improving the Nigerian education system and addressing the persistent challenges of teacher attrition, low productivity, and declining student performance (Ololube, 2013).

Financial remuneration is one of the primary determinants of teachers' motivation in Nigeria. Low salaries have been a persistent issue in the education sector, leading to widespread dissatisfaction among teachers. Many educators struggle to meet their financial obligations, which affect their job commitment and productivity. Adeyemi and Oladipo (2019) held that fair and competitive salaries play a crucial role in boosting teachers' morale and reducing turnover rates. However, the irregular payment of salaries, delays in promotions and lack of financial incentives contribute to teacher demotivation in many Nigerian schools.

The working environment is another significant factor affecting teachers' motivation. Many Nigerian schools, particularly in rural areas, suffer from inadequate infrastructure, insufficient teaching materials, and overcrowded classrooms. Poor working conditions make it difficult for teachers to effectively perform their duties, leading to frustration and decreased job satisfaction. Studies have shown that teachers who work in well-equipped and conducive environments demonstrate higher levels of motivation and engagement (Bennell & Akyeampong, 2012). Providing necessary resources, improving classroom conditions, and ensuring adequate facilities can significantly enhance teacher motivation in Nigerian schools.

Opportunities for career growth and professional development also influence teachers' motivation. In Nigeria, limited access to training programs, workshops, and higher education opportunities restricts teachers' ability to enhance their skills and advance in their careers. Professional development not only improves teaching effectiveness but also increases job satisfaction and motivation. Teachers who receive regular training and have clear career progression paths are more likely to remain committed to their profession (Okeke & Mtyuda, 2017). Implementing structured training programs and creating opportunities for career advancement can significantly improve teachers' motivation in Nigerian schools.

School leadership and administrative support play a crucial role in shaping teachers' motivation. Principals and school administrators who exhibit strong leadership, provide guidance, and recognize teachers' efforts create a positive work environment that fosters motivation. In contrast, authoritarian leadership, lack of recognition, and poor communication between teachers and school administrators contribute to job dissatisfaction and decreased motivation. Olayiwola (2020) maintained that participatory leadership and inclusive decision-making processes enhance teachers' sense of belonging and commitment to their work Encouraging supportive leadership practices in Nigerian schools can improve teacher morale and job satisfaction.

Recognition and rewards are essential components of teacher motivation. Teachers who feel valued and appreciated for their hard work and contributions are more likely to remain dedicated to their profession. However, many teachers feel underappreciated, with limited recognition from school authorities, parents, and the government. Implementing recognition programs, such as teacher awards, public appreciation events, and performance-based incentives, can boost motivation and reinforce a culture of excellence in schools (Uche & Enwere, 2021).

Job security and stability significantly impact teachers' motivation in the Nigerian school system. Many teachers, particularly those in the private sector, face job insecurity due to contractual employment, lack of pension benefits, and the risk of sudden job termination. This uncertainty creates anxiety and reduces commitment to teaching. Ensuring job security through policies that guarantee permanent employment, pension schemes, and protection against arbitrary

dismissal can enhance motivation and attract more qualified individuals to the teaching profession (Adebayo & Yusuf, 2018).

The socio-cultural perception of teaching as a profession affects teachers' motivation. Teaching is often regarded as a low-status profession, with many teachers experiencing social and professional undervaluation. This perception discourages young graduates from pursuing teaching careers and demotivates those already in the profession. Elevating the status of teaching through advocacy, improved remuneration, and professional development opportunities can enhance motivation and attract more competent individuals to the profession (Eze, 2016).

Work-life balance is another important factor influencing teachers' motivation. Many teachers face excessive workloads, long working hours, and additional responsibilities beyond their teaching duties in schools. These challenges contribute to stress, burnout, and reduced motivation. Schools that implement workload management strategies, provide mental health support, and promote a balance between work and personal life report higher levels of teacher motivation and job satisfaction (Bakker & Demerouti, 2017). Government policies and education reforms also play a significant role in shaping teachers' motivation in Nigeria. Policies that prioritize teacher welfare, provide adequate funding for education, and ensure fair treatment of educators contribute to a motivated teaching workforce. However, frequent policy changes, lack of implementation, and bureaucratic inefficiencies often undermine teachers' confidence in the system. Ensuring consistency in educational policies, involving teachers in decision-making processes, and addressing systemic issues can enhance motivation and commitment among educators (Akinbote, 2015).
